The area will be within the Western Navajo Fairgrounds, but away from the vending area. You will be required to adhere to load-in and loadout times to ensure the safety of all attendees, staff, and vendors. A Vendor Pass displayed on your Rear-View mirror WILL be required prior to driving on the fairgrounds. **Vendor Passes:** Each Vendor will be issued up to six (6) vending passes. No one under the age of 18 years old will be issued a pass without the permission of the Fair Manager. Outdates or recalled products will be subject to removal or confiscation. Alcohol and drugs are strictly prohibited. Alcohol and Drugs: Anyone found under the influence of alcohol and/or a controlled substance will be immediately removed from the Tuba City Spring Festival Fair premises and will no longer be allowed to vend. Law Enforcement will be notified and criminal charges will be filed. ALL SALES ARE FINAL. NO REFUNDS WILL BE ISSUED.
